Lotus Capital Trading Ltd. (" we", " us" or "Lotus Capital Trading"), is an international business company registered in Saint Lucia under registration number: 2023- 00068. We help traders and Introducing Brokers achieve their business goals and personal ambitions. Our business is built on integrity and trust, offering an industry leading combination of dynamic products, competitive trading parameters and premium, one- on-one service.

It is Lotus Capital Trading's mission to enable the personal ambitions and business goals of FOREX traders and IBs, through underpinning dynamic products with competitive trading parameters and a premium customer experience.

2. COMMITMENT

Lotus Capital Trading is committed to protecting the privacy of all personal information which it obtains from you, including the information obtained during your visits to this website or the provision of other services to you. Lotus Capital Trading will only use your personal information in accordance with this Privacy and Security Policy and otherwise in accordance with the Privacy and Data Protection Act in Santa Lucia.

3. Lotus Capital Trading COLLECT PERSONAL INFORMATION

Lotus Capital Trading collects certain personal information in order that it may meet the needs of its customers. By collecting certain personal information, Lotus Capital Trading can monitor and improve the services which it offers to its existing and potential customers

. We will use this information for the following purposes: establishing and maintaining your account, providing our services to you, improving our services, regulatory notifications and marketing.

4. WHAT INFORMATION DOES Lotus Capital Trading OBTAIN?

You consent to Lotus Capital Trading using your personal information for the above-stated purposes. You also consent to Lotus Capital Trading transferring your personal information out of Saint Lucia where this is necessary for Lotus Capital Trading to fulfill its contractual obligations to you. Please note that Lotus Capital Trading only transfers personal information to organizations out of Saint Lucia if Lotus Capital Trading has assessed the organization as having appropriate controls and safeguards in place to protect your personal data.

6. WHO MAY Lotus Capital Trading DISCLOSE THIS INFORMATION TO?

Lotus Capital Trading may be required to provide your personal information to the regulator and government bodies from time to time. Lotus Capital Trading may also disclose your personal information to:

- financial institutions and other similar organizations that ideals within the course of its corporate activities, or those that are nominated by you.
- external service providers and professional advisers (which may be located overseas) that provide services to Lotus Capital Trading.
- any organization at your request or any persons acting on your behalf, including your financial adviser, broker, solicitor or accountant.
- any third parties where this is necessary to process a transaction or provide services which you have requested; or
- any authority to whom Lotus Capital Trading is required to disclose such information by law. Please note that Lotus Capital Trading does not sell or provide your personal information to third parties for marketing purposes.

7. UPDATING YOUR INFORMATION

You may inform Lotus Capital Trading at any time that your personal details have changed or that you wish Lotus Capital Trading delete personal information we hold about you by emailing us . Lotus Capital Trading will change or delete your personal information in accordance with your instructions, except to the extent that we are required to hold your personal information for regulatory or legal purposes, to provide you with the services you have requested or to maintain adequate business records.

We may charge a nominal fee to cover the cost of verifying the application and locating, retrieving, reviewing and copying any material requested.
